## **Privacy Statement** Last updated: June 2024

Your privacy is important to us. This privacy statement explains the personal data Applii Solutions processes, how Applii Solutions processes it, and for what purposes.

This statement applies to the interactions Applii Solutions has with you and the Applii Solutions services listed below, as well as other Applii Solutions that display this statement.

## Personal data we collect

Applii Solutions collects data from you, through our interactions with you and through our solutions and products. You provide some of this data directly, and we get some of it by collecting data about your interactions, use, and experiences with our solutions and products. The data we collect depends on the context of your interactions with Applii Solutions and the choices you make, including the solutions and products and features you use. We may also obtain data about you from third parties.

You have choices when it comes to the technology you use and the data you share. When we ask you to provide personal data, you can decline. Where providing the data is optional, and you choose not to share personal data, features like personalization that use such data will not work for you.

#### i. Personal Information

Personal information that we may collect from you includes your name, contact information, IP addresses, product and service selections, and other such information to help us identify you.

Here are the various ways in which we collect personal information from you: Please note that this is not an exhaustive list and we may add more points to it in the future:

- When we communicate with you at any point as a customer or a prospective customer
- Whenever you visit our website or make use of the platform that we provide
- If and when we register you as an end-user of our products or services or both
- When you provide information to us using any of the forms on our website for contacting us

#### ii. Non-personal Data

If you use our website and/or services, then we may collect some non-personal data and information about you through automatic functionalities on the site. This data may includes but is not limited to details such as name of the browser used to access our website, type of device, other technical information like the operating system and Internet providers. We may collect this information via Analytics functionality or other tools of similar status.

#### **Retention**:

We retain personal data associated with your purchases for the periods specified by applicable laws, which vary by region.

## How we use personal data

Applii Solutions uses the data we collect to provide you with rich, interactive experiences. In particular, we use data to:

- Provide our products, which includes updating, securing, and troubleshooting, as well as providing support. It also includes sharing data, when it is required to provide the service or carry out the transactions you request.
- Improve and develop our products.
- Personalize our products and make recommendations.
- Advertise and market to you, which may include sending promotional communications, targeting advertising, and presenting you with relevant offers.

We also use the data to operate our business, which includes analyzing our performance, meeting our legal obligations, developing our workforce, and doing research.

In carrying out these purposes, we combine data we collect from different contexts (for example, from your use of different Applii Solutions' products) or obtain from third

parties to give you a more seamless, consistent, and personalized experience, to make informed business decisions, and for other legitimate purposes.

Our processing of personal data for these purposes includes both automated and manual (human) methods of processing. Our automated methods often are related to and supported by our manual methods. For example, our automated methods may include artificial intelligence (AI), which we think of as a set of technologies that enable computers to perceive, learn, reason, and assist in decision-making to solve problems in ways that are similar to what people do. To build, train, and improve the accuracy of our automated methods of processing (including AI), we manually review some of the predictions and inferences produced by the automated methods against the underlying data from which the predictions and inferences were made. This manual review may be conducted by Applii Solutions employees or vendors who are working on Applii Solutions' behalf.

#### Reasons we share personal data

We share your personal data with your consent or to complete any transaction or provide any product you have requested or authorized. We can also share with vendors working on our behalf; when required by law or to respond to legal process; to protect our customers; to protect lives; to maintain the security of our products; and to protect the rights and property of Applii Solutions and its customers.
